# **NEW BOARD MEMBER BIOGRAPHIES**

# Larry Adams - Director class of 2016

I was fortunate to obtain a Pembroke Welsh Corgi in 1979 - a little red and white female. As she grew on, prompted by a friend, I entered her in a local dog show - my first ever. She won Winners Bitch for a 4pt major. Needless to say I was hooked and thus Gaylord was born! She finished her championship quickly. The first time she was bred it produced a male AM/CAN CH Gaylord's Bobbindobber ROMX. Bobbindobber won Best of Breed at the Potomac Corgi Specialty in 1986 with an entry of 416. The first Norwich to come to Gaylord was Ronnells Baby Ruth which was obtained from Sandra Stemmler and Sue Weaver. Baby Ruth did well in the show ring. Gaylord has produced many Champions over the years and through the dogs have made many cherished friends and acquaintances all over the world. Gaylord has imported 12 dogs from the UK. There have been many special dogs over the years ... a Pembroke - CH Perrymist Red Affair ROMX produced a famous son CH Caralon's Casper At Gaylord ROMX who is rated as Number 5 Sire in the history of the breed. Another special dog imported was a Norwich - CH Titanium Master Chef (Puck) - bred by Mrs. Eileen Needham. Puck won his Championship easily and produced well. He lived a long healthy life. Type, temperament and healthy dogs has been the foundation of Gaylord. I began judging in 1997. My judging career has taken me around the world. A few important highlights - 2004 Norwich National - the last year it was at the old show site and Best of Breed at the 2008 Pembroke Welsh Corgi Specialty. I am currently approved to judge Best In Show, Herding Group and 11 Terrier Breeds, Junior Showmanship and all the Misc Breeds. I am in the process of applying for additional terrier breeds.

#### Marilyn Jacobs - Director class of 2016

I have been involved in AKC events since 2002, which is when I purchased my first Norwich Terrier, Mr. Biggs. Since that time, I have owned and campaigned several terrier breeds, including Airedales, Welsh Terries, Miniature Bull Terriers, Smooth and Wire Terriers, and Lakeland Terriers. Glengariff's Bethpage Black RN AX OAJ – was given the NTCA Versatility Award. We have three Norwich in our home – Libby, Paige, and Riley - who is close to finishing his Grand Championship title. I am also a member of the Norwich Terrier Club of Greater Chicago and the Nassau/Suffolk Owner Handler Association. I look forward to serving on the Board of the NTCA and giving back a small portion of what this breed and community have given me.

# Annual Report of the AKC Delegate, October, 2014

AKC delegates meet quarterly in the months of March, June, September, and December. I attended the first three of the meetings as well as the preceding days of committee meetings, and I am scheduled to go to Orlando in December during the week of the AKC Invitational. Delegates are encouraged to volunteer at the two day show following our meetings as ring stewards, working at the AKC booth, selling catalogs or as needed.

There will once again be a "Meet the Breeds" in Orlando. Instead of the customary "Meet the Breeds" held every Fall at the NYC Javits Center, there will be a similar opportunity sponsored by AKC to showcase our breed at the site of the Westminster Kennel Club show in February.

At the June Delegates' meeting there was a vote to remove eligibility restrictions for the selection of club delegates. Although a majority of clubs approved the change (I voted per NTCA Board instructions for change.) it was defeated. A two-thirds approval was needed for change.

The NTCA Board asked me to work with AKC in an effort to exclude the large entry numbers from the Montgomery weekend shows which skew the point system in Pennsylvania, New Jersey, New York, and Delaware. A way was found by designating all four of these shows as Designated Specialties" rather than "Supported Entries". We were able to make the change immediately, and starting in October, 2014, these shows will not be included in the point schedule counts. With the point schedule lowered, we should always have five point majors at our National Specialties. There is also the possibility, if numbers are great enough, to be able for Reserve Winners to get a three point major.

AKC has an ongoing campaign to use social media to change the negative perception the general public has of the AKC and purebred dogs. We are told that these proactive efforts are making a difference.

The AKC is encouraging all clubs to offer amateur owner competition at their shows. It is thought to increase entries and introduce new people to the sport.

If any of you have recently registered a puppy, you will have noted that AKC follow up includes information offered on area all breed clubs and clubs offering training classes as well as upcoming events including conformation shows and performance trials.

At the September Delegates" meeting, I was asked to read a statement to the delegate body informing other delegates of our club's problems of finding mixed breed dogs in our Norwich registry. It is the opinion of the Registry Integrity Committee that many of these dogs are the result of the AKC's Administrative Registration Research Service (ARR). There appears to be interest among a number of delegates who were unaware of the extent of our problems and of services the AKC offers to commercial breeders through the ARR.

I appreciate the honor of serving as your AKC Delegate.

#### NTCA HEALTH COMMITTEE REPORT - FALL 2014

In consideration of a limited time to present the report, The Health Committee will concentrate the summary of its efforts on the main focus of our work-- Upper Airway Syndrome in Norwich Terriers.

#### CONCLUDED RESEARCH

- 1) 16-case study authored by Dr.Lynelle Johnson at UC Davis is already published. Dr. Johnson's paper is the first peer-reviewed, scientific article documenting the UAS in Norwich Terriers. Out of 16 Norwich Terriers in the study, 12 dogs exhibited clinical signs of breathing difficulties and 4 dogs never showed any clinical signs of respiratory problems. Upon laryngoscopic examination all 16 dogs were found to have recognizable anatomical obstructions to air flow in the upper airway, even those dogs that never showed clinical signs. Dr.Johnson's study suggest a widespread occurrence of UAS in Norwich Terriers. Documenting the condition was a critical step towards establishing diagnostic protocols and surgical measures to be explored in further clinical studies. (Note: The dissertation study conducted 10 years ago in Switzerland at the University of Berne on UAS in Norwich Terriers was never published, and could not be used to secure funding and academic interest for UAS in our breed.)
- 2) Dr. Chris Zink's study, Legacy of Love Program, in which breeders and owners of Norwich Terriers submitted dogs of all ages that had passed away for post mortem examination, has been concluded. By the time you read this report, the members had a chance to hear a pre-view results of Dr.Zink's research at the annual NTCA Health Seminar. During the three years of the study (2011-2014), Dr. Zink received 39 Norwich Terriers 18 adults over 2 years of age, and 21 puppies up to 5 months of age. She also received 5 Norfolk Terriers and 42 other dogs of a variety of other breeds to be used as controls. In her presentation, Dr. Zink generously shared the preliminary results of this extensive study of the physical characteristics of the larynx and trachea of Norwich Terriers. We are looking forward to the published article, and thank Dr.Zink for the most generous sharing of her work pre-publication.

#### ONGOING GENETIC RESEARCH

Dr.Jeffrey Schoenebeck continues his research mapping the genes and associated regions affecting UAS in Norwich Terriers: bones, cartilage and soft tissue. This is Dr.Schoenebeck's 8<sup>th</sup> year studying genetics of brachycephaly in canines and the fourth year of his focus on our breed.

After a setback of Canine Health Foundation denying our request for a grant to continue funding Dr.Schoenebeck's research, a new source of funding was secured in April and the study resumed without interruption.

Dr.Schoenebeck continues his work at Roslin Institute at University of Edinburgh. Genetic mapping of Norwich Terriers is being performed on DNA material collected by us in the USA and also on DNA samples purchased from the University of Berne. We are pleased about the progress of this long-term effort.

#### NEW CLINICAL STUDY OF UAS TO BE ANNOUNCED SOON

We are working with Dr.Brydon Stanley at Michigan State University on developing further clinical research of UAS in Norwich Terriers, with the goal of:

- 1) establishing diagnostic protocol and surgical procedures for veterinarians,
- 2) establishing a standardized test for breeders,
- 3) establishing comprehensive breeding guidelines.

Once the design of the study is complete we will be seeking NTCA members participation in this important research. Dr.Stanley has been accepting critical cases of UAS ahead of the official announcement of the study.

#### **Breeder's UAS Self-Reporting Form**

The Health Committee is urging breeders to use our "UAS Self-Reporting Form" for every planned breeding. The form is easy to implement and it is an extremely simple, yet accurate method of eliminating at least severely symptomatic dogs from our breeding programs. The form was already distributed to members twice in club mailings, along with an explanatory narrative, and was included within the pages of The News, and as an additional insert. Please do not breed any Norwich Terrier litters without first using the UAS Self-Reporting Form.

# Informational video on UAS for Norwich Terrier owners

The NTCA Board approved the Health Committee's proposal to make a short educational video about UAS in Norwich Terriers. We will start its production in January 2015.

# Planned Health Seminar and Clinic in 2015

The NTCA Board accepted our request for funds that would allow us organizing a clinic in fall 2015, in case a standardized test for UAS is established by then.

The Health Committee's work is not limited to efforts to eliminate Upper Airway Syndrome, but given the time constraints and member proposed motions by Blair Kelly, this report concentrated on providing in-depth information on the committee's work devoted to UAS, what we consider the most pressing health issue for our beloved breed.

# ILLUSTRATED STANDARD COMMITTEE REPORT – SEPT. 2014

In the past year, the following has been accomplished by the Committee:

The *Illustrated Guide to the Standard of Norwich Terriers* was published and all NTCA members (as of 10/1/13) either received a free copy during MCKC weekend or were mailed a copy.

All AKC judges who are approved for Norwich Terriers were mailed a copy in November 2013. On January 28th, an announcement was posted on the JUDGES-L discussion list inviting other AKC judges to request a complimentary copy, and more than 50 additional copies were mailed as a result.

I continue to mail several copies each month to permit and aspiring judges of Norwich Terriers. The Certificate of Registration was received from the US Copyright Office.

Approximately 40 copies have been sold through Notions online store.

The Illustrated Standard is available for purchase through Notions on the NTCA website for \$10 plus \$2.50 postage.

Two others were in and out so fast that I was merely a way station. Thank goodness. I do get many calls and emails but have learned to try to place dogs right from the point of origin. I still have to turn down many dogs that are not purebred.

Rescues call many of their charges Norwich only hoping someone will take them in only to find out they have been duped. Then they call me again. So very sad.

# NTCA BREED STANDARD COMMITTEE REPORT - SEPT. 2014

The November 2013 NTCA Membership Mailing contained the 2013 NTCA Breed Standard Committee Report that included a request for member input on the tail issue. The Committee received eight responses and the overwhelming majority was strongly opposed to changing the breed standard to allow for undocked tails. Below are quotes from the responses:

"I do not support any change to our standard... I hope that your committee will continue to support our breed standard as currently written."

"Times have changed and we are now seeing far more Norwich in the ring with tails. Our priorities should be to encourage a healthy exchange with other countries to broaden the gene pool, to allow performance dogs to have the clear advantage of the tail..."

"We don't need to follow Europe, etc. or other breed clubs. Research why? This is a matter of decision from the NTCA body of members. I believe the "No" vote has indicated the interest of our Members."

".... I do not support changing our standard to accommodate the regulations of foreign kennel clubs."

"I am adamantly opposed to allowing Norwich with tails."

"I would like to inform the committee that I am totally against changing our breed standard regarding tail-docking. I would also like to thank the committee for their effort in settling this issue."

The Breed Standard Committee was successful in correcting the Norwich Terriers color and marking choices for on-line AKC registration. The AKC paper registration form matches up with the breed standard. However, the AKC on-line registration system added three questionable colors (red grizzle, tan, wheaten) and three markings (black markings, black mask, black points), which do not exist in our breed. The AKC honored the NTCA request and removed the three questionable colors and the three nonexistent markings as registration choices.

The Breed Standard Committee has been working with the AKC on publishing a letter to Norwich judges reminding them that the Norwich is a docked breed and that NTCA has no intention of changing the breed standard.

The Breed Standard Committee continues to work with the AKC and the Parent Clubs of other docked breeds on the tail issue.

# REGISTRY INTEGRITY COMMITTEE (RIC) REPORT - OCT. 2014

A significant change in our Committee occurred when our Chair and leader, Carol Suggs, resigned her position as Chair recently. Fortunately for all of us, she is remaining on the Committee and will continue to contribute her knowledge and expertise. Carol has been behind all the work and successes of the RIC, starting with achievements in 2005. Up to the point Carol stepped down as Chair earlier this year, approximately 250 dogs have been removed from the Norwich Terrier Registry. In addition, Carol has mentored the Committee members and taught us what to look for in our quest to clean up our Registry. The Committee would like to extend our gratitude to Carol for her steadfast dedication and persistence to protect the Norwich Terrier Registry.

The Committee's most recent project is what we call the Peggy Project. Peggy is an AKC registered Norwich Terrier and she is black. A Mars Wisdom Panel DNA test revealed she is 50% Cairn Terrier, 25% West Highland White Terrier, and 25% mixed breed. She is the result of AKC's Administrative Research Registration (ARR) service. It is a free service AKC offers to commercial breeders to register with AKC any breeding stock currently registered with another registry. To quote AKC's description of this service,

"Our free Administrative Research Registration (ARR) service allows AKC staff to conduct pedigree research to determine registration eligibility for dogs upon customer request. AKC can register dogs originating from AKC registrable (their spelling) stock. Dogs may qualify for registration if pedigrees show no break in AKC lineage and all dogs originate from AKC registrable stock."

Peggy proves that the ARR service can be a pathway for registering mixed breeds or purebred dogs that are not Norwich. Her pedigree included a dog that would have been only 2.5 months old at the time he sired a litter, dogs with no stud book dates, and identity theft. On July 28, 2014, we submitted a request to AKC to remove Peggy from the Norwich Terrier Registry along with several other dogs with similar pedigree discrepancies. The result was that a total of 61 AKC registered Norwich Terriers were removed.

For 2015, the committee plans to focus on working with AKC to make changes in their policies and procedures that are allowing dogs other than purebred Norwich Terriers into the AKC Norwich Terrier Registry. And, of course, we will continue to look for dogs in our Registry that are not Norwich Terriers and work toward their removal.

# **FALL 2014 NEWS REPORT**

The Fall 2014 *Norwich Terrier News* will be my final issue after 18 years as co-editor/editor. I have enjoyed serving as editor, but definitely feel it is time to retire since I am no longer much involved with the NTCA or with the world of Norwich Terriers.
