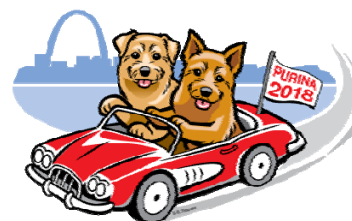

### Notice to Exhibitors

- The trial is open to all Norwich and Norfolk Terriers fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP).
- Running order will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible.
- If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.
- After closing date refund for bitches in season will be amount paid less \$10 per day processing fee.
- Withdrawals before the closing date will receive full refund less \$7 processing fee.
- Refunds are mailed in the time frame of seven days before to seven days after the event.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE ENTRIES CANNOT BE ENTERED IN THE TRIAL.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- No Flexi Leashes allowed at Purina Farms
- Exhibitors are responsible for being at the ring gate when it is their turn to run.
- Please be courteous and pick up after your dog.
- Dogs under four months of age are prohibited at AKC Agility Trials
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of Missouri

### Course Familiarization / Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in the class. A warm-up jump will be provided for each ring.

### Move-Up Regulations

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, from Trial 1 to Trial 2 provided that the request is received in writing by the Trial Secretary, no later than 15 minutes following the last dog finishing the last course of Trial 1. Request must be in writing.

**The Norfolk Terrier Club** does not agree to binding arbitration as set forth on the Official AKC Entry Form for the event.

**Awards**

Ribbons will be awarded 1st—4th place in each jump height class to dogs with qualifying scores. Green Ribbons will be awarded to all dogs with qualifying scores.

High Scoring Norwich Terrier earning a Qualifying Score in Standard of Trial One will receive a Norwich themed prize.

Any Master level Norwich Terrier or Norfolk Terrier earning Double Q in either Trial will receive a QQ pin offered by ABBA Dogs.

Each Norfolk Terrier entered will receive a breed related item offered by Norfolk Terrier Club.
