The Elections Ballot and cover letter for 2024 were drafted, submitted to the Board for approval and, after approval, mailed on September 21, 2022 to 264 NTCA Members, which was all voting Members except myself. 106 complying Elections Ballots were received by me = a 40.15% response, less than the 43.8% response received for 2023. The Elections votes were counted and the results were sent to the Show Chair.

In accordance with the Chairperson's Job Description, the process of securing Judges for the 2025 NTCA National Specialty Show in Montgomery County, PA was started by obtaining a list from AKC of all AKC Judges approved or permitted to judge Norwich Terriers and a list from NTCA of voting Members.

The Nominations Ballot, cover letter and Judges list were drafted, submitted to the Board for approval and, after approval, mailed on April 23, 2023 to 260 NTCA Members, which was all voting Members except myself. 71 complying Nominations Ballots were returned to me = a 27.3% response, less than the 31.9% response for the 2024 nominations. One more was received but not considered because it was not in NTCA Ballot envelope.

The Nominations votes were counted and the results were sent to the Show Chair on June 16, 2023. When the Show Chair's response is received, the Elections will proceed.

Performance Committee Report from October 2022 through September 15, 2023

In October of 2022 we held our face-to-face Performance Committee meeting. In attendance were Kandy Adams, Rainee Johnson, Betty McDonnell and Ursula Walsh Several topics were discussed.

The Versatility Chart added the new Novice Earthdog title Novice Earthdog and assigned two (2) points. We also voted unanimously not to add points for "Excellent" titles for Senior and Master Earthdog since we do give extra points for multiple Excellent/Master titles in other venues. We made other small changes to the Versatility chart which the BOD approved.

We discussed our hosting the trial in October 2023 which we unanimously agreed to do either on Monday or Tuesday.

The committee asked Joan to research donating to disaster trailers which the committee will revisit in 2023.

Also, the committee wanted the history of profits for the years we have hosted to keep with the Performance records. Joan has those records.

Joan brought up creating "history" of Norwich in each performance venue; however, that chart or volunteers to write the "history" has not yet happened.

The Committee had five additional Zoom meetings during 2023 to discuss several topics.

#### February Zoom meeting:

We discussed awards /trophies for Palmyra and we unanimously agreed to purchase gear bags rather than purchase the Wendall August plates. The remaining Wendall August plates in Joan's possession will be used as "trophies" for qualifying Norwich who participate in Earthdog on October 10, 2023. The BOD approved our purchase of gear bags. Joan will transport the 6 Wendall August plates to the trial chair , Maria Sacco, for the Earthdog trial and will request all unused plate be returned to NTCA via Joan.

Another topic we discussed was the 15<sup>th</sup> year celebration. In addition to an agility "trophy" for high in Standard and an obedience and rally "trophy" for high in trial, we voted unanimously that each participant would receive a gift ( to be determined at a later date.)

We also discussed adding additional members to our committee. The committee agreed we need additional members and requested that the BOD approve our asking Dale Martins and Patty Fornelli. After the BOD approved our request, Joan asked Dale and Patty to serve on the committee and they agreed.

#### March Zoom meeting:

We discussed the Meredith Dwyer tribute. And We unanimously agreed to have a "tribute" and not an award. Or trophy. We plan to have a table with pictures, a brief tribute before the trial begins on October 3, 2023 and a raffle or silent auction of one of Meredith's prints (donated by Betty McDonnell) With input from her daughter those proceeds will go to a cause that Meredith supported. The BOD approved.

#### June Zoom meeting:

We discussed our weeklong club responsibilities or hosting a day in Palmyra 2023. Our jobs are "Set Up/ Break Down" and "ribbon order and inventory" for the whole week. Lynn Stonesifer, the assistant chair, has done a spectacular job creating an excel spreadsheet that will enable us to keep records each day. Since Lynn can't be there the entire four days, Dale volunteered to be in charge when Lynn leaves. Everything for Palmyra is settled.

THE BOD approved our using Wendall August plates for earthdog.

The longest part of our meeting concerned the 2026 Purina Specialty. After a lengthy discussion of many issues: the size of the club, the number of performance dogs, the number of volunteers required for each performance/companion venue, the challenges faced in 2018( combined Norwich/Norfolk specialty) with agility after the conformation events, we unanimously voted to only sponsor rally and obedience on Friday, May 29, 2026. To ensure success of hosting obedience/rally event, we agreed to allow the first five days of entries for Norwich before the trials open to all breeds. We discussed awarding special prizes for placements and high in trial. The committee recognized the need to commit so that Magda could secure the appropriate space and equipment so that we can move forward with planning. We also voted to offer prizes/awards to ALL Norwich qualifying or participating in events that may be offered by either the Mississippi Kennel Club or the Missouri Rhineland Cluster. Those prizes/awards have yet to be determined and more discussion will be needed.

Betty agreed to look into who the judges for rally and obedience were in 2018 since they were local, well-respected, and easy to work with and brought their own stewards. She will also check to see about a locally use Trial Secretary/ Superintendent and volunteered to be the chairperson as long as she could also show her dogs.

#### July Zoom meeting:

We revisited our discussion of Purina 2026 . Our requested date for Rally and Obedience, May 29, 2026 was not available indoors. Therefore, we agreed to hold the Rally and Obedience trial on Thursday, May 28, 2026. Betty agreed to be the trial chair; however, we cannot move forward with planning until we are assured the indoor facility is available on that date. Joan asked Jill Lowry, a club member and rally judge, if she would agree to be the judge for Rally. Jill accepted the invitation. We are waiting on details/ specifics from Purina.

We also discussed other demos/intros that could be held during the four -day specialty to provided performance-based fun/informative/ activities for those attending, This is what we have so far:

- 1. Magda Chiarella agreed to do an "Intro to Scent Work"
- 2. Denise Faulkner agreed to do "Intro to ratting" and agreed to look for a CGC Evaluator if we decide to offer that.
- 3. Kandy Adams agreed to do a "Freestyle Demo"
- 4. Joan Krantz and Rainee Johnson agree to "Intro to Performance/ Life Fundamentals"

We discussed special awards for Norwich participating in other All Breed events that may be offered during the four days. That information is not yet available.

Since assuming the role of Rescue & Rehoming Chair in November 2022, I have followed up on fifteen inquiries or alerts of a Norwich Terrier in need of a new home. Some came directly to me via the website; others were forwarded to me by members. My involvement has ranged from a few phone calls to verify a post on social media to many hours spent working to place a dog.

Two of the cases, both senior females (Sophie 10 and Olivia 11 1/2 years old), both living in Maryland, were true rescue situations. Each had been rehomed at least once after the deaths of their original owners. Both were successfully placed in loving homes. Olivia went to a senior couple who had applied online and had experience with rescues. Sophie went to a senior couple in my own network who had recently lost their dog.

In three cases, I supported breeders – to varying degrees – in rehoming a total of four Norwich. In three other cases, I advised the owners to reach out to the breeder (with the caveat that if they needed my help to let me know). The balance of the cases were dogs being placed by other rescue organizations and, except for one, the dogs were not purebred Norwich. In the case of the purebred Norwich, the Scottish Terrier Rescue group was working directly with the breeder place them. In instances that made sense, I reached out to my list of applicants living in the general area of the rescue to make them aware of the opportunity and refer them to the rescue organization.

With Amanda Kozora's help and guidance, we updated the Rescue & Rehoming webpage and application. The result is a steady flow of applicants for rescues, now numbering more than 125 in almost every state (even Hawaii) and Canada, since November. Anecdotally, more than half are people who have or have had Norwich. While I don't respond to all (they receive an autoreply), I do respond to any phone calls or email inquiries.

I am grateful to former Rescue & Rehoming Chair Ursula Walsh for her initial coaching and advice, as well as members of the Club who have offered to and/or helped on select cases. I am especially grateful for the guidance and support of Magda Chiarella, Amanda Kozora, and the entire Board as I navigated the first year in this role, including helping me with an especially challenging case (that had a very happy ending)!

Upon request by then NTCA President, Judy Laffey, the committee investigated a stud dog being offered to her by a woman who was not a member and appeared to have no knowledge of breeding, showing and health testing in Norwich Terriers but showed some interest in learning. An AKC pedigree

(foreign-bred) and photos were included in the letter sent to Judy. Upon investigation, committee member Barbara Wyttenbach did discover the dog is Ukrainian bred and is indeed purebred. She also discovered that the dog's grandsire was scoped in Austria and has a good score. Judy agreed to offer guidance to the woman with the stud dog. We are so fortunate to have an international member on our committee.

An NTCA member reported to RIC that she found the questionable use of a foreign dog's pedigree in the US. She knew the dog in question was bred and owned by a person currently living in a foreign country. The committee investigated and discovered that the foreign breeder bred two dogs with the same name, kept one and exported the other to the US. The NTCA member was notified.

A woman from the state of WA notified NTCA that she had been in the process of buying (from a Cairn breeder) what was represented as a purebred Norwich puppy when (through other sources) she discovered it was a mix. The woman confronted the breeder who did admit it. She brought to our attention that the breeder writes about Norwich/Cairn mix puppies on her website and also a wait list for people wanting this mix. To date, we have not found any of her mixes to be AKC registered. Fortunately, the story ends well as the woman was able to connect with a legitimate Norwich breeder and now has a puppy. She just wanted to alert us and others to be cautious and not end up buying a mixed puppy that is represented as a purebred Norwich. We appreciate members notifying the Corresponding Secretary or RIC of anything that is worthy of investigating to determine its legitimacy. Trophy Committee Report:

We would like to sincerely thank the membership for donating to the 2023 trophy fund. We really appreciate your support.

We will be offering Wendall August items and Centaur rosettes again this year at MCKC. Some of the rosettes have a bit more embellishment this year as we look to continue to make everything more regal and fitting of our National specialty.

For the supported entries at Hatboro 1 & 2 and Devon we are offering engraved metal keepsake awards from Woodbury Pewter and Hodges Badge Company, and rosettes from Centaur.

This year we will have a new trophy for Winners Dog: The John W. Francisco Memorial Challenge Trophy, bringing our total to eight active trophies. We thank Marilyn Jacobs for organizing, fundraising and acquiring the new trophy.

Custom fitted trophy cases were made for the six club trophies that were previously stored in plastic storage containers. The cases are very well made and we are pleased that the trophies will now be properly protected for transporting and annual storage.

Earlier this summer we closed the old storage unit and moved everything to a new storage unit in Macungie PA, which is about two miles from Macungie Memorial Park the site of the Hatboro and MCKC shows. The new location will make it a lot more convenient to access club materials during our National week.

Working closely with the Show Chair we are hopeful to once again have our own dedicated ring and an early start time at MCKC. Our intention is to get photographs done earlier and more efficiently so that members can get to the group rings and luncheon with less stress than last year, and so that the trophy committee and Show Chair have sufficient time to setup and take down our ring. We have also asked for more tables to display and stage our expanded offering of trophies and awards.

We are already brainstorming for 2024 which will be our club's fifteenth anniversary!
